4. Upon demand by surety, applicant must deposit collateral in the form and in the amount requested by Surety.
5. Surety shall have the absolute right to procure it's release from future liability under said bond and Surety in hereby released from any damages applicant may sustain by reason of such release.
6. Surety will be permitted upon reasonable notice, to examine any and all books, records or assets related to the bond coverage.
7. The above agreement shall bind applicant and his/her heirs, executors, administrators, successors and assigns, jointly and severally.
8. To pay all bond premiums in advance at each anniversary until the Surety's liability thereunder is terminated.

THE APPLICANT HEREBY AGREES AS FOLLOWS:

The Undersigned individual as applicant for surety credit or as an indemnitor for a surety transaction hereby acknowledges that individual and/or business credit history may be a necessary requirement in the underwriting and evaluation of surety bonds. Therefore, the undersigned does hereby consent to and authorize Smith Manus and their agents to obtain at any time, as they deem necessary, to order his or her personal consumer credit report.
